Simone Fleming | CEO





Premises Liability

Managing Workplace Injury



Employers

Even before an incident occurs, you can do a great deal to prepare by having a dedicated procedure for a work place injury in place. Is there a reporting procedure? There needs to be an assigned point person for injury situations and standardized plan of action.

Once a dedicated procedure is implemented and the employees are notified of these best practices, managing a workplace accident or injury has significant clarity.

Claims Investigation Procedures

CLAIMS

Alethinios Investigators personally contact the policyholder, and often conduct on-site investigations of the accident scene when appropriate. Know the history of the case and the issues to be resolved. Good results depend on good case preparation.

You need to know the type of injury, body part involved, current medical condition or diagnosis, physical limitations or restrictions. Additionally, know the coverage and limits of the insured's policy.

Surveillance



Effective surveillance reduces the paid costs on claims. Criminal prosecution differs from the WCB Hearing arena, in that we must establish proof beyond a reasonable doubt rather than a preponderance of evidence (which may suffice at the Hearings level).

Experience has shown us that some injured workers will prolong their return to work by malingering or exaggerating their disabilities. Surveillance investigation should be initiated when you have good reason to believe the worker is misrepresenting his / her disability.

Work Injury Investigations

Work Injury Claim

Responsible insurance Professionals understand the important need to objectively review each claim based on consistent parameters. Effective investigations will reduce the paid costs on claims, eliminate high reserves and increase leverage for settlement.

An effective investigation starts with the correct philosophy, approach, and understanding of what is currently in place at your organization. Getting the investigation right means lower workers' comp costs and improved injured worker outcomes.

Third Party Product Liability



Product liability is the result of personal injury caused by a defective product. The designer, manufacturer, distributor and / or retailer can be held liable. The product must have been used in the manner intended in most cases. Normal wear and tear of the product is not reason for cause.

Misuse and abuse of the product are defenses in a product liability lawsuit. Also, bear in mind that personal injury lawsuits have filing timelines and requirements.

Bodily Injury Investigations




The challenge to the insurers is that both liability and damages should be investigated concurrently. Often one or both are either overlooked or incomplete, having an adverse impact on outcomes.

To improve overall BI Claims outcomes, it is critical that claims investigations consistently focus on the fundamentals. When done properly, bodily injury claims investigations, evaluations and settlements take a significant amount of time, knowledge and expertise.

Cad Diagrams | Simulations | Animation

The purpose of the crash diagram is to take the guesswork out of the investigation and to demonstrate the location of vehicles and other related physical evidence. It allows reconstruction of the crash scene to determine how it happened. Major cases, such as Fatal Crashes require a finished diagram.

our scene investigators imports aerial imagery, total station or RTK GPS Points, and Point Cloud Data into your scene. Designated vehicles and other objects are added to create scale diagrams of your accident sequence.
